The above service includes travel within 30 minutes of my business address. I'm happy to travel further to see you, but any travel time over 30 minutes will be charged at my hourly rate and applies to both the outward and return journeys.

The home consultation fee is payable before the home consultation takes place. The home consultation can be used as a stand-alone service, with no requirement to purchase another service from me. If further work is needed, it will be charged at an agreed rate. Receiving the home consultation does not guarantee further work.

Virtual Consultation

I will do my utmost to call/contact you at the date and time agreed on your online booking, however, I cannot accept any liability for loss (financial or otherwise) if, for reasons beyond my control, the call cannot take place as booked.

Interior Design

The client must have received the Home Consultation service before taking up the Interior Design service, as this service cannot be purchased separately.

Online Interior Design

The client must have received the Virtual Consultation service before taking up the Online Interior Design service, as this service cannot be purchased separately.

Online interior design will be carried out over email. The fixed fee online interior design package includes the complete design of one room, including one set of 2D visuals, a scale floorplan and a private Pinterest board with links so that you can purchase all items. One hours worth of

follow up work is included for making changes to the scheme, and sourcing additional or alternative items. The online interior design fee covers a two month period from an agreed start date. Any additional design work outside of this time period will be charged at my hourly rate.

Procurement

As I pass on my trade discounts to the client, any defects or problems with any of the goods supplied remain the responsibility of the supplier. In the event of a problem, I will liaise with the supplier and do my best to rectify the situation to your satisfaction, but am not financially liable for any loss resulting from faulty or goods not as advertised. The procurement service is not available to those purchasing the online interior design package.

Installation Management

The contract for any work carried out is between you and the tradesperson. Although I will do my best to resolve any issues, I cannot be held responsible for any delays or problems arising from their work. I take no payment from the tradespeople I recommend.
